- PENN Becomes First U.S. Operator to Voluntarily Undergo RGC's Rigorous Accreditation Process -

WYOMISSING, Pa. – February 2, 2023 – PENN Entertainment (Nasdaq: PENN) ("PENN" or the "Company") is pleased to announce that its online gaming platforms, Barstool Sportsbook & Casino and HollywoodCasino.com, have received RG Check iGaming Accreditation from the Responsible Gambling Council (RGC). PENN Entertainment subsidiary, PENN Interactive, became the first U.S. operator to voluntarily undergo this accreditation, which is widely regarded as one of the most comprehensive responsible gambling accreditation programs in the world.

PENN has now achieved RG Check accreditation across its Interactive division with subsidiary 'theScore Bet' [securing the accreditation](#) prior to its launch in Ontario. At the time, theScore Bet became the first prospective private market operator in Ontario to achieve the accreditation.
